

NUMOV's Annual General Meeting 2006

This year's Annual General Meeting of the German Near and Middle East Association (NUMOV) on the 29th of May, 2006 took place once again in the Federal Foreign Office in Berlin. Additional to the appointment of Gerhard Schröder as Honorary Chairman of NUMOV, the Annual General Meeting endorsed further new board members. Herbert Bodner, Chairman of the Board of Bilfinger Berger AG, took over Carlos Möller's position on the NUMOV board, and Jan Kupfer, Executive Board Member of Bayerische Hypo- und Vereinsbank AG has taken over the mandate of Ronald Seilheimer. Last year, the association was able to record the best result since its founding for the 9th year in a row. This is reflected in the membership statistics. In 2005, the Association recorded a net growth in its membership of 52 companies.
